Approval of Votes and Proceedings of Monday, 27th June, 2011:

Mr. Speaker announced that he had read through, and was satisfied with the Votes and Proceedings of Monday, 27th June, 2011, which was thereafter approved by unanimous consent, subject to the following amendment.*

On page 3, item 4, line 2, to *delete* the word "on" and *insert* the word "from" *instead* thereof.

Matters of Urgent Public Importance:

Hon. Aliu, Peter (Etsako East) rose in his seat to draw the attention of the House to the heavy rainfall of Sunday, 26th June, 2011, which wreaked havoc on Igiode Community in his Constituency. He added that, apart from the houses of some Community members, whose roofs were blown off, the only Primary School in the locality (Igiode Primary School) also had its roof blown off. He thereafter urged the State Government through the Ministry of Women Affairs and Social Development, to come to the aid of the Community.

Other Members who spoke on the matter equally aligned themselves with the issues canvassed by the Honourable Member representing Etsako East.

Concluding, Mr. Speaker while sympathising with the people of Igiode Community in Etsako East Local Government Council, he directed the State Emergency Relief Agency, the Transition Committee Chairman of Etsako East Local Government Council, Ministry of Women Affairs and Social Development, and the Ministry of Education to visit the Community and carry out palliative measures on the Primary School.

He however enjoined the Honourable Member representing Etsako East to monitor these bodies with a view to ensuring that the directive of the House was carried out.

i. Motion to Correct this Present Assembly from Fourth Assembly to Fifth Assembly.

Whereas, this present Assembly i.e. (2011 - 2015) is supposed to be named or called the Fifth Assembly.

Whereas, the First Assembly in Edo State was between 1991 - 1993 while the Second Assembly was between 1999 - 2003, Third Assembly was between 2003 - 2007, Fourth Assembly was between 2007 - 2011 while this present Assembly 2011 - 2015 should be the Fifth Assembly not Fourth Assembly.

Whereas, this correction is done for record purposes.

Be it Therefore Resolved by this Honourable House that:

1. The Clerk of Edo State House of Assembly should take note and make appropriate correction for record purposes.

On order being read, the motion was deffered till a later date.
