Whereas, the First Assembly in Edo State was between 1991 - 1993 while the Second Assembly was between 1999 - 2003, Third Assembly was between 2003 - 2007, Fourth Assembly was between 2007 - 2011 while this present Assembly 2011 - 2015 should be the Fifth Assembly not Fourth Assembly.

1. The Clerk of Edo State House of Assembly should take note and make appropriate correction for record purposes.
